### Objectives and investment policy

*Objective* - The Fund aims to achieve income and capital appreciation by investing mainly in debt securities of issuers which are domiciled or which carry out a large portion of their economic activity in the Asia ex-Japan region. The Fund may also, on an ancillary basis, invest in other emerging market and developed market debt securities (including but not limited to US government securities).

At times, the fund manager may also invest in other types of eligible securities as detailed in the prospectus.

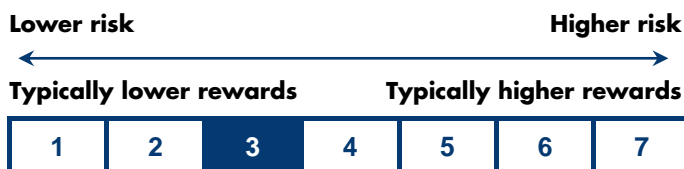
*Designed for* - The Fund is designed for investors who seek for long-term income and capital growth from an actively managed portfolio.

*Subscription/Redemption/Conversion* - Investors can buy, sell and switch shares in the Fund on any day which is a business day in Luxembourg.

*Dividends* - No dividend will be declared and paid to the shareholders of this share class.

### Risk and reward profile



The category is based on synthetic data and is based on price movements in the share class (volatility), and may not be a reliable indicator of future risk. The risk category is not guaranteed to remain unchanged, and may change over time.

*Market risk* - The Fund invests in debt securities or debt-related securities, and these can rise or fall due to factors such as the fluctuation of global bond markets and interest rates.

*Emerging markets risk* - Investing in emerging markets carries a higher risk (e.g. larger price fluctuations) than a developed market. Some of the investments may be subject to low liquidity, making them hard to buy or sell at short notice.

*Credit risk* - Issuers of bonds or other debt securities may default on their obligations to pay back the principal or interest payments. Changes in economic and political environments and the financial condition of issuers may lead to a credit ratings downgrade, affecting the value of investments held by the Fund.

*Operational risk* - The inability to make timely security purchases or disposals due to administrative/settlement problems may result in missed potential gains or undesirable losses to the Fund.

*Exchange rate risk* - Changes in foreign currency exchange rates may adversely affect the value of the investments held in the Fund.

*Regional risk* - The Fund invests mainly in countries of the Asia ex-Japan region and tends to be more volatile than global funds.

*Foreign investment risk* - Some countries in the Asia ex-Japan region may prohibit or impose restrictions on investments by foreign investors and such restrictions may change from time to time.
