### Objectives and investment policy

*Objective* - The Fund aims to achieve long term capital growth, by investing mainly in equities and equity-related securities of companies that are engaged in health care and health care related businesses in the countries of Asia Pacific region, or such companies which have significant business operations there.

The Fund may invest in China A-Shares through Stock Connect, which is a programme developed for the purpose of mutual stock market access between Hong-Kong and China.

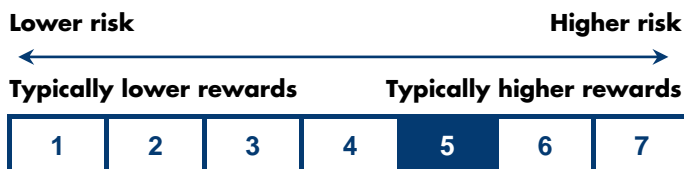
*Designed for* - The Fund is designed for investors who seek for long-term capital growth from an actively managed portfolio.

*Subscription/Redemption/Conversion* - Investors can buy, sell and switch shares in the Fund on any day which is a business day in Luxembourg.

*Dividends* - No dividend will be declared and paid to the shareholders of this share class.

### Risk and reward profile

*Emerging markets risk* - Investing in emerging markets carries a higher risk (e.g. larger price fluctuations) than a developed market. Some of the investments may be subject to low liquidity, making them hard to buy or sell at short notice.

*Operational risk* - The inability to make timely security purchases or disposals due to administrative/settlement problems may result in missed potential gains or undesirable losses to the Fund.

*Exchange rate risk* - Changes in foreign currency exchange rates may adversely affect the value of the investments held in the Fund.

*Sector-specific risk* - The Fund holds a concentrated portfolio focusing on a health care theme and may be more volatile than a diversified portfolio.

*Regional risk* - The Fund invests mainly in countries of the Asia Pacific ex Japan region and tends to be more volatile than global funds.
