WHAT IS THE PRODUCT?

The fund is a sub-fund of Beresford Funds ICAV (the "ICAV"), an open-ended umbrella type Irish collective asset-managed vehicle with variable capital, with segregated liability between its sub-funds and is established as an Undertaking for Collective Investment in Transferable Securities (UCITS). **Term:** The product has no fixed term. The fund may be terminated at any

The fund aims to provide total return, taking into account both capital and income returns, by investing primarily in equities (shares) of companies around the world.

The fund targets shares of companies that have the potential to deliver lower levels of fluctuations in share price. Investment in China A equities shall not exceed 20% of the net assets of the fund. The fund may invest up to 100% of its net asset value in derivatives (complex financial instruments) such as index future contracts, forwards and options. These instruments may be used by the fund to gain exposure to the underlying security, to reduce the fund's exposure to a security/ currency or to generate income for the fund. The fund is actively managed.

The performance of the fund is monitored relative to a global equity benchmark, MSCI World. The fund does not use the index as an investment limitation and does not intend to track the index. The fund's portfolio is not

WHAT HAPPENS IF SUMMIT ASSET MANAGERS LIMITED IS UNABLE TO PAY OUT?

In the event of insolvency of the Depositary, the fund may suffer a financial loss however, this loss is mitigated to certain extent by the segregation of the assets. The Depositary is liable to the fund for losses arising from negligence or intentional failure to properly fulfil its obligations pursuant to the UCITS Regulation (subject to certain limitations).
