

Key Investor Information Document: This document provides you with key investor information about this Fund. It is not marketing material. The information is required by law to help you understand the nature and the risks of investing in this Fund. You are advised to read it so you can make an informed decision about whether to invest.

Barings China A-Share Fund (the "Fund") a sub-fund of Barings Investment Funds plc (the "Umbrella Fund") Class F USD Acc - ISIN No. IE00BL2HXZ13 (the "Share Class")

Barings Investment Funds plc is an Open Ended Investment Company. Baring International Fund Managers (Ireland) Limited is the Manager of the Fund.

OBJECTIVE AND INVESTMENT POLICY

Objective: To provide long-term capital growth by investing in the People's Republic of China (the "PRC").

Investment Policy: The Fund invests at least 70% of its total assets in China A-Shares and other QFII/RQFII Permitted Securities listed on PRC Stock Exchanges. China A-Shares are shares of mainland China-based companies (domestic shares quoted in Chinese renminbi (RMB) that trade on the PRC Stock Exchanges, namely the Shanghai Stock Exchange and the Shenzhen Stock Exchange. Other QFII/RQFII Permitted Securities include corporate or treasury bonds and warrants listed on PRC Stock Exchanges.

The Fund is also permitted to invest to a lesser extent in China B-Shares, shares of Hong Kong listed companies with a Chinese parent or in cash and cash-equivalent securities. China B-Shares are different from China A-Shares with China B-Shares being quoted in foreign currencies (such as USD) rather than RMB for China A-Shares.

The Fund may use derivative instruments for both investment and hedging purposes. The return on a derivative is linked to movements in an underlying instrument referenced by the derivative such as currency or interest rates. The base currency of the Fund is USD.

Distribution Policy: N/A - Income will be rolled up into the value of your investment.

Dealing Frequency: Daily. Investors can buy and sell their shares on demand on each Business Day (as defined in the Prospectus).

Benchmark: 'MSCI China A Onshore (Total Net Return) Index'. The Fund is actively managed and is not designed to track the Benchmark so its performance may deviate materially from the Benchmark. The investment manager has complete discretion in making investments and is not constrained by the Benchmark. The Fund may invest significantly in instruments which are not included in the Benchmark. The Benchmark is used only for risk management and performance comparison purposes. The investment manager may consider, for example, issuer exposures, sector weights, country weights and tracking error in each case relative to the Benchmark but does not use the Benchmark as an investment limitation.

RISK AND REWARD PROFILE



The risk number is based on the rate at which the value of the simulated data of the Fund has moved up and down in the past, and is an indicator of absolute risk.

The following risks may not be captured by the risk and reward indicator:

- Country or region specific Funds have a narrower focus than those which invest broadly across markets and are therefore considered to be more risky

- China may face more political, economic or structural challenges than developed countries. Coupled with less developed regulation, this means your money is at greater risk.
- The Fund can hold smaller company shares which can be more difficult to buy and sell as they may trade infrequently, in small volumes and their share prices may fluctuate more than those of larger companies.

The charges you pay are used to pay the costs of running the Fund, including marketing and distributing costs. These charges reduce the potential growth of your investment.

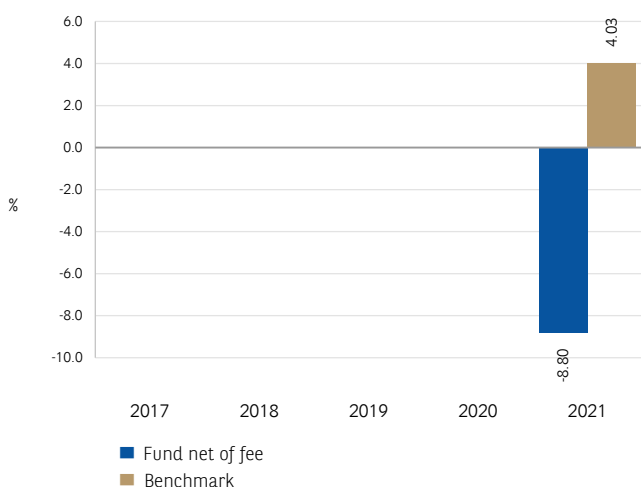
