

**Key Investor Information Document:** This document provides you with key investor information about this Fund. It is not marketing material. Barings International Fund Managers (Ireland) Limited is the Manager of the Fund (the "Manager").

### OBJECTIVE AND INVESTMENT POLICY

**Objective:** To seek a maximum total rate of return primarily from current income, while minimising fluctuations in capital values.

**Investment Policy:** The Fund invests primarily in a diversified portfolio of North American and European short-term investment grade fixed income securities. An investment grade fixed income security is one which carries a lower (but not zero) degree of risk than high yield fixed income securities, as such investment grade fixed income securities typically carry a lower rate of interest than high yield fixed income securities. The Fund is permitted to invest in a range of fixed income instruments including instruments issued by the US Treasury, US Government Agencies, US Government Sponsored Enterprise, US Local, City and State Governments and Agencies and US and non-US corporations. The fixed income instruments in which the Fund invests may include corporate bonds and notes, treasury obligations, sovereign issues, covered bonds, convertible instruments and commercial paper. The Fund is also permitted to invest in debt securities backed by a pool of assets (which can range from loans and mortgages to credit card receivables), other Funds, cash and cash-equivalent securities and money market instruments. Up to 10% of the Fund's net assets can be invested in securities rated lower than BBB- by Standard & Poors (S&P) or Fitch, or rated lower than Baa3 by Moody's Investor Service or the equivalent rating of another internationally recognised rating agency, provided these securities are rated BB- or higher by S&P or the equivalent rating of another internationally recognised rating agency. The average portfolio duration of the Fund is expected to range between 0 and 3 years under normal market conditions. Duration measures the sensitivity of the assets to interest rate risk. The longer the duration the higher the sensitivity to changes in interest rates.

The Fund may use derivative instruments for both investment and hedging purposes. The return on a derivative is linked to movements in an underlying instrument referenced by the derivative such as currency or interest rates. The base currency of the Fund is USD.

**Share Class Currency Hedging:** This share class engages in currency hedging using derivative instruments to seek to limit the shareholder's currency risk by reducing the effect of foreign exchange rate fluctuations between the share class currency and the base currency of the Fund.

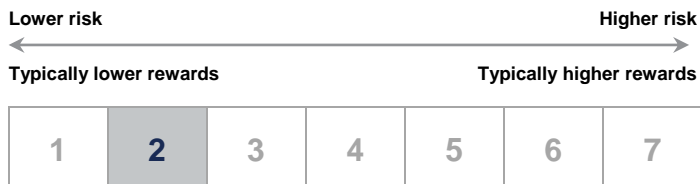
**Distribution Policy:** N/A - Income will be rolled up into the value of your investment.

**Dealing Frequency:** Daily. Investors can buy and sell their shares on demand on each Business Day (as defined in the prospectus).

**Benchmark:** Bloomberg Barclays U.S. Government 1-3 Year Index'. The Fund is actively managed and is not designed to track the Benchmark so its performance may deviate materially from the Benchmark. The investment manager has complete discretion in making investments and is not constrained by the Benchmark. The Fund may invest significantly in instruments which are not included in the Benchmark. The Benchmark is used only for risk management and performance comparison purposes. The investment manager may consider, for example, issuer exposures, duration, sector weights, country weights, credit ratings and tracking error in each case relative to the Benchmark but does not use the Benchmark as an investment limitation.

### RISK AND REWARD PROFILE

Low rated (high yield) or equivalent unrated debt securities of the type in which the Fund will invest generally offer a higher return than higher rated debt securities, but also are subject to greater risks that the issuer will default.

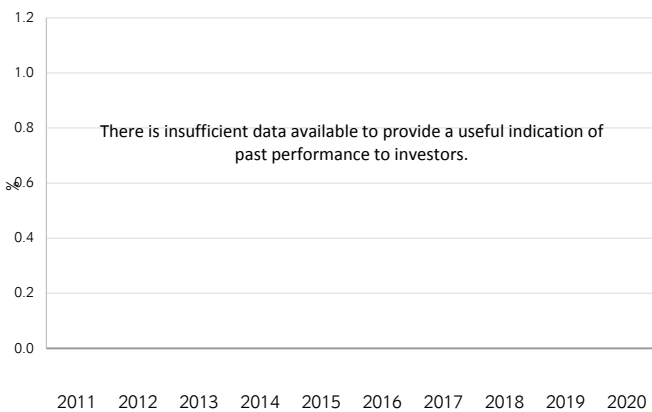
The entry and exit charges shown are maximum figures. In some cases you might pay less - you can find this out from your financial adviser.
