WHAT IS THIS PRODUCT?

Type:

The product is a type of collective investment scheme – specifically, a shareclass within a sub-fund of an umbrella type open-ended investment company with variable capital and segregated liability between sub-funds authorised by the Central Bank of Ireland as a UCITS pursuant to the Regulations. Your investment will take the form of shares in the Fund.

Term:

The product is not subject to any fixed term or maturity date. The Manager may not terminate the Fund unilaterally. The directors of Insight Global Funds II plc may terminate the Fund in accordance with the terms of the Prospectus.

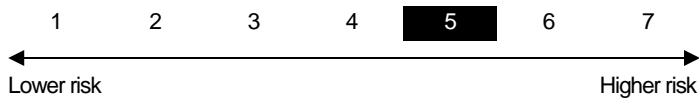
Objectives:

- The Fund aims to generate a total return, comprising both income and capital growth, by investing primarily in a portfolio of fixed and floating rate bonds issued by corporates, banks and other commercial issuers, governments, governmental agencies, supranational entities and public international bodies. The Fund may also invest in asset backed securities (ABS), notes, debentures, certificates of deposit, commercial paper, floating rate notes and convertible bonds. The Investment Manager follows an actively managed total return strategy that invests across the full credit spectrum (i.e. investment grade to non-investment grade corporate, sovereign and asset backed credit from developed and emerging market issuers). The strategy is based on a top-down approach that combines long-term strategic views with shorter-term tactical views alongside bottom-up analysis of individual credits.
- The Fund promotes: i) a minimum environmental and/or social standard that seeks to mitigate or avoid practices that the Investment Manager deems environmentally and/or socially detrimental. Exclusion criteria are used to achieve this minimum standard ii) investments in higher scoring issuers in terms of their ESG profile, as determined by the Investment Manager and iii) investments in lower carbon intensity issuers as determined by the Investment Manager.
- The Fund will allocate at least 10% of the Fund's Net Asset Value in aggregate to Use-of-proceeds Impact Bonds and/or Impact Issuers. Investors should be aware that the ESG criteria as detailed in the Environmental/Social policy within the Supplement may change over time.
- The Fund may also use financial derivative instruments (FDIs) for investment purposes as well as for hedging and/or efficient portfolio management purposes.
- The Fund may in particular use forward foreign exchange contracts and currency swaps, future and options to hedge currency risk back to Sterling, futures, options, total return swaps, interest rate swaps, interest rate swaptions and inflation swaps to manage interest rate risk, inflation risk, credit risk and duration exposure as well as using credit default swaps ("CDS") to provide a measure of protection against defaults of debt issuers. Investment in sub-investment grade bonds and debt securities will not exceed 50% of the Net Asset Value of the Fund.
- The Fund seeks to outperform its reference benchmark (SONIA) by 4% per annum after fees over rolling five-year periods whilst being mindful of the Investment Objective. However, a positive return is not guaranteed and a capital loss may occur.
- The Fund is actively managed and has full discretion in the selection of investments. This Fund may not be appropriate for investors who plan to withdraw their money within 5 years.
- Shares can be bought from and sold back to the Fund on any business day in Ireland.

- Class B Sterling Shares are accumulation shares. This means that income from the Fund's investments will be reinvested.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?



The risk indicator assumes you hold the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less than you invested.

Risk indicator

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as class 5 out of 7, which is a medium-high risk class. This rates the potential losses from future performance at a medium-high level, and poor market conditions will likely impact the capacity of the fund to pay you.

The product is subject to the following risks which are not included in the indicator above. If the product is denominated in a currency other than the official currency of the member state where the product is being marketed, the return, when expressed in the official currency of the member state where the product is being marketed, may change depending on currency fluctuations. The product may use derivatives for investment purposes. Whilst this is not intended to cause larger, more frequent changes in the Fund price or increase its risk profile, derivatives are inherently volatile and the product may be exposed to additional risks and costs as a result. The Fund may invest in high yield bonds where there is a greater risk to capital and income than a similar investment in government or investment grade bonds. WHAT HAPPENS IF INSIGHT INVESTMENT MANAGEMENT (EUROPE) LIMITED IS UNABLE TO PAY OUT?

The assets of the Fund are held in safekeeping by the Depositary. In the event of the insolvency of the Manager, the Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the insolvency of the Depositary, or someone acting on its behalf, the Fund may suffer a financial loss and there is no compensation or guarantee scheme in place which may offset, all or any of this loss. This risk is mitigated by the fact that the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund.

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

- GBP 10 000 is invested.
