### WHAT IS THIS PRODUCT?

#### Type:

The product is a shareclass within a sub-fund of an umbrella type open-ended investment company with variable capital and segregated liability between sub-funds authorised by the Central Bank of Ireland as a UCITS pursuant to the Regulations.

#### Term:

The product is not subject to any fixed term or maturity date. The Manager may not terminate the Fund unilaterally. The directors of Insight Global Funds II plc may terminate the Fund in accordance with the terms of the Prospectus.

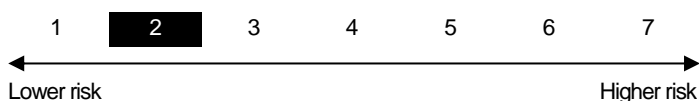
#### Objectives:

- The Fund aims to generate a return for investors investing primarily in a portfolio of fixed and floating rate bonds and debt securities, mainly those with a maturity of up to five years, issued by corporates and other commercial issuers and banks. The Fund may also invest in other debt securities such as asset backed securities (ABS), debentures, loan instruments or participations where such are money market instruments, notes and other similar corporate debt instruments. The Fund's benchmark is Markit iBoxx GBP Corporates & Collateralized 0-5 years index and the Fund will measure its performance against this.
- Corporate debt securities may be acquired with warrants attached. The Fund will mainly seek to invest in debt securities of investment grade quality and may, to a lesser extent, invest in sub-investment grade quality high yield securities.
- The ABS will be unleveraged and will not embed a derivative element. The ABS are generally secured debt obligations and include residential mortgages, commercial real estate mortgages, secured small business loans, credit card receivables and consumer loans and other types.
- The Fund will invest on a worldwide basis. The Fund's Base Currency is Sterling. The Fund may invest in non-Sterling denominated assets which will typically be hedged back into Sterling.
- The Fund is actively managed meaning the Investment Manager has a high level of discretion as how to make investments for the Fund.
- The Fund may also use financial derivative instruments (FDIs) for investment purposes as well as for hedging and/or efficient portfolio management purposes.
- The Fund may not be appropriate for investors who plan to withdraw their money within 5 years.
- The Depository of the Fund is Northern Trust Fiduciary Services (Ireland) Limited.
- Class S Sterling Shares are accumulation shares. This means that income from the Fund's investments will be reinvested.
- Insight Global Funds II plc is an umbrella investment company. The assets of the Fund are segregated from those of other sub-funds in Insight Global Funds II plc. You can find out more information about the umbrella and the Fund in the "Important Information" section of the Prospectus.

Investment in the Fund may be appropriate for investors who have knowledge of, and investment experience in, this particular financial product and understand and can evaluate the strategy, characteristics and risks in order to make an informed investment decision. Potential investors should have a low sensitivity to changing market conditions and be willing to set aside capital for at least five years.

### WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?



The risk indicator assumes you hold the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less than you invested.

#### Risk indicator

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

**We have classified this product as class 2 out of 7, which is a low risk class. This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact the capacity of the fund to pay you.**

The product is subject to the following risks which are not included in the indicator above. If the product is denominated in a currency other than the official currency of the member state where the product is being marketed, the return, when expressed in the official currency of the member state where the product is being marketed, may change depending on currency fluctuations. The product may use derivatives for investment purposes. ## WHAT HAPPENS IF INSIGHT INVESTMENT MANAGEMENT (EUROPE) LIMITED IS UNABLE TO PAY OUT?

The assets of the Fund are held in safekeeping by the Depositary. In the event of the insolvency of the Manager, the Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the insolvency of the Depositary, or someone acting on its behalf, the Fund may suffer a financial loss and there is no compensation or guarantee scheme in place which may offset, all or any of this loss. This risk is mitigated by the fact that the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund.

### Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs.
