
Investment Policy

The fund invests in the shares of a range of companies based in, or with significant business activities in Emerging Markets.

Essential features of the fund:

- The fund invests primarily in equity and equity related securities of companies, at least 80% of which will be dividend-paying securities, that derive at least 50% of their revenues from business activities in emerging market countries principally in Asia, Eastern Europe, Middle East, Africa and Latin America.
- The equity and equity related securities in which the fund may invest are listed and traded on Recognised Exchanges worldwide.
- Under normal market conditions the fund intends to invest in between 25 and 75 stocks.
- The fund may invest in securities of companies with a wide range of market capitalizations and in companies domiciled throughout the world.

Risk and reward profile


